**PERKHIDMATAN BOT BERLESEN (WATER TAXI) BAGI URUSAN TURUN NAIK PELAUT
SEPANJANG TEMPOH PERINTAH KAWALAN PERGERAKAN DI KAWASAN LABUHAN,
PELABUHAN KEMAMAN**

Lanjutan daripada Pekeliling Pelabuhan Bil. 07/2021 bertarikh 18 Februari 2021, dimaklumkan bahawa aktiviti bagi urusan turun naik pelaut atau bekalan makanan ke kapal di Kawasan Labuhan, Pelabuhan Kemaman menggunakan perkhidmatan bot berlesen perlu mendapat kebenaran bertulis dari Pejabat Laut Kemaman.

Hanya kategori pelaut dari kapal yang beroperasi di perairan Terengganu sahaja dibenarkan untuk turun dan naik ke kapal di Kawasan Labuhan, Pelabuhan Kemaman.

Lokasi pendaratan yang dibenarkan adalah di Jeti Kastam lama, Chukai, Kemaman sahaja.

**WATER TAXI BOAT SERVICES FOR SEAFARERS EMBARKATION & DISEMBARKATION
DURING THE PERIOD OF MOVEMENT CONTROL (MCO) AT KEMAMAN ANCHORAGE,
PORT OF KEMAMAN**

Following to the Port Circular No. 07/2021 dated 18th February 2021, please be informed that seafarer shore leave or food provision supply to ships at anchorage area, Kemaman Port using a licensed boat service (water taxi) required an written approval from Kemaman Marine Department Port Office.

Only seafarers from ships operating in Terengganu waters are allowed to embark / disembark the ship at anchorage area, Kemaman Port.

The landing point allowed for these purpose is Customs Jetty (old), Chukai, Kemaman.
