**LANTIKAN EJEN ATAU OPERATOR UNTUK

**APPOINTMENT OF AGENT OR OPERATOR
FOR LEAVING CRAFT AT MARINA TIOMAN
MORE THAN 30 DAYS**

This is to notify that any ship owner who intends to leave the craft at Marina Tioman for significant period or 30 days or more must appoint an agent or operator to be responsible for the management of the craft and the owner shall provide all documents pertaining contracting or appointing to the Marine Department for review and authentication.

The owner is required to submit the application form as per attachment MPT 01 and all the necessary documents for review and approval.

This circular will be enforced immediately.
