LARANGAN BAGI MENGADAKAN ATAU MENGANJURKAN SEBARANG AKTIVITI SOSIAL DI LAUT TERMASUK SUKAN DAN REKREASI DI WILAYAH UTARA.

Masyarakat Perkapalan telah dimaklumkan bahawa mengikut Perutusan Khas YAB Perdana Menteri Mengenai COVID -19 pada 16 Mac 2020, berkaitan dengan situasi ancaman virus COVID-19 yang semakin serius dan bagi mencegah penularan baharu wabak ini kepada lebih ramai rakyat, Kerajaan telah memutuskan untuk melaksanakan Perintah Kawalan Pergerakan bermula 18 - 31 Mac 2020, di seluruh Negara. Perintah Kawalan Pergerakan ini dibuat di bawah Akta Pencegahan dan Pengawalan Penyakit Berjangkit 1988 dan Akta Polis 1967 yang meliputi enam (6) perkara, antaranya larangan secara menyeluruh pergerakan dan perhimpunan ramai di seluruh Negara termasuk aktiviti keagamaan, sukan, sosial dan budaya.

Selaras dengan Perintah Kawalan Pergerakan tersebut, Jabatan Laut Malaysia Wilayah Utara telah mengambil ketetapan untuk tidak membenarkan sebarang aktiviti sosial di laut seperti *Parasailing, Sunset Cruise, Island Hopping, Snorkeling, Diving* dan apa juga aktiviti sosial yang berkaitan di laut bermula 18 - 31 Mac 2020 atau sehingga suatu tarikh yang akan dimaklumkan kelak.

PROHIBITION FOR ANY SOCIAL ACTIVITIES ON SEA INCLUDING SPORTS AND RECREATION AT SEA IN THE NORTHERN REGION.

The Shipping Community is hereby informed that according to the Prime Minister's Special Message on COVID-19 on 16 March 2020, in relation to the increasingly serious situation of the COVID-19 virus and to prevent the spreading of the new pandemic to more people, the Government has decided to implement the Movement Control Order from 18 - 31 March 2020 throughout the Country. This Movement Control Order was made under the Prevention and Control of Infectious Diseases Act 1988 and the Police Act 1967 covering six (6) items including a comprehensive prohibition on public movements and gatherings throughout the Country including religious, sports, social and cultural activities.

In line with the Movement Control Order, the Marine Department of Malaysia, Northern Region has decided not to allow any social activities at sea such as Parasailing, Sunset Cruise, Island Hopping, Snorkeling, Diving and any other relevant social marine activities from 18 - 31 March 2020 or until further notice.
